A. Chief Appraiser report:

1. Pictometry, appraisals, mapping, collections, conferences and in-house training. Daisy Watson, deputy Chief Appraiser, attended the Chief Appraiser Institute.

Doug Smithson, Chief Appraiser, noted that he serves on the Texas Association of Appraisal Districts Legislative Committee. As of right now, (lawmakers) have already introduced over 120 bills that affect this office and the session isn't even started yet. A perennial topic is a law that would make board of direction member, appraisal review board members and the chief appraisers elected officials. This law has not been enacted.

Doug also said the office has undergone multiple staff changes. In 2022, the district had 6 new hires in a staff of 16.

Daisy said the employees are working on in-house training. She also noted that we're not having a huge price drop in the market. Homes are on the market for longer days. Higher interest rates and inflation are helping cool what had been a sizzling market. New construction is trending upward in the county.

Appraiser, Randy Jones retired in December.

2. TAAD Conference. Conference is in February. For those that attend, will need to register before January 28, 2023.
